BY CLICKING 'I ACCEPT', YOU ARE DEEMED TO HAVE ACCEPTED THE FOLLOWING TERMS AND CONDITION, INCLUDING OUR DATA PROTECTION AND PRIVACY POLICY. If you do not agree to the terms and conditions of this EUSA, you shall not click 'I Accept' and the Licensor is unwilling to license this Software to you. In such event, you shall promptly contact the Licensor for instructions on returning the Software.

SOFTWARE SUBSCRIPTION

The Software is protected by copyright laws and international copyright treaties, as well as other intellectual property and trade-secret laws and treaties. **The Software is being licensed, not sold.**

1. Subscription of Software

a. <u>Subscription Term</u>

The subscription term of the Software is calculated by days of the calendar month ("**Subscription Term**"). The commencement date of the Subscription Term will start once the payment of the subscription is made and expire at 12 am on the last date of Subscription Term as purchased by the Licensee. The Subscription Term shall be displayed in the about box.

b. <u>Extension</u>

c. <u>Reminders</u>

2. <u>License</u>.

- a. <u>Grant of License</u>. - c. <u>Multi-User</u>. Subject to payment of the subscription price for multi-users, the Software is licensed with multi-user or networked license terms, only the permitted number of the licensed users may use the Software on a total of one computer(s) or workstation(s), or personal digital assistant(s), or "smart phone", or one such other electronic device(s) for which the Software was designed ("Client Device"), unless otherwise set forth herein. The component parts of the Software may not be used individually or jointly in full or in part on more than one Client Device, unless otherwise set forth herein. Non-compliance of this license restriction is strictly forbidden and shall be considered a material breach of this EUSA and among all other remedies available to the Licensor, including but not limited to immediate payment to the Licensor for all license fees due and owing to the Licensor, shall cause this EUSA.

3. <u>Term</u>.

a. <u>Term.</u> Regardless of the location of the Software, the Licensee is responsible for strict compliance with any and all of the terms and conditions of this EUSA. This EUSA will expire automatically should the Licensee chooses not to extend the Subscription Term and will terminate automatically if the Licensee defaults in payment of the subscription for the Software or fails to comply with any of the limitations or other requirements described herein, and such expiry or termination shall be in addition to and not in lieu of any criminal, civil or other remedies available to the Licensor. When this EUSA expire or terminates, the Licensee shall no longer be authorised to use the Software and must immediately cease use of the Software.

4. Ownership Rights.

a. <u>Ownership of Software</u>. The Software is the property of the Licensor and is protected copyright laws and other intellectual property laws, and international treaty provisions. - c. <u>Restrictions</u>. The Licensee shall not copy, translate, disassemble, or decompile, nor create or attempt to create, by reverse engineering or otherwise, the source code from the object code of the Software. Notwithstanding the foregoing, the Licensee may make one (1) copy of the Software solely for back-up purposes. The Licensee shall not use the Software for the benefit of a third party, not rent, timeshare or use the Software in service bureau processing. - a. **Disclaimer**. Unless required by the applicable law and agreed to you in writing, you subscribe to this Software on a 'as is where basis' without any warranties or conditions of any kind either express or implied.
- b. <u>Indemnification</u>. The Licensee shall hold harmless, indemnifies the Licensor against all actions, claims, proceedings, demands, losses, damage, costs and expenses arising from and against all claims, defence costs (including reasonable expert and attorneys' fees), judgments and other expenses arising out of or on account of: (i) alleged infringement or violation of any patent, trademark, copyright, trade secret or other proprietary rights with respect to the modification and customization performed by the Licensee of this EUSA; or (ii) any negligent act, omission, or wilful misconduct by the Licensee in the performance of this EUSA.
- C. <u>Data</u>. THE LICENSEE ACKNOWLEDGES THAT ANY DATA ENTRY, CONVERSION OR STORAGE IS SUBJECT TO THE LIKELIHOOD OF HUMAN AND MACHINE ERRORS, MALICIOUS MANIPULATION, OMISSIONS, DELAYS, AND LOSSES, INCLUDING, BUT NOT LIMITED TO, INADVERTENT LOSS OF DATA OR DAMAGE TO MEDIA THAT MAY RESULT IN LOSS OR DAMAGE TO THE LICENSEE AND/OR ITS PROPERTY, AND/OR ITS DETRIMENTAL RELIANCE ON MALICIOUSLY MANIPULATED DATA. THE LICENSOR SHALL NOT BE LIABLE FOR ANY SUCH ERRORS, OMISSIONS, DELAYS, OR LOSSES. This EUSA is exclusively governed by the laws of the Sage entity that you are contracting with as set out in the column entitled "Governing Law" of the table set out in Exhibit A, without reference to conflicts of law principles. In the event of a dispute or legal action between the parties, they agree to waive any objections to personal jurisdiction, and agree to service of process and exclusive venue of the courts of the country of the Sage Group plc entity that you are contracting with as set out in the column entitled "Court of Jurisdiction" in the table set out in Exhibit A. The application of the United Nations Convention of Contracts for the International Sale of Goods is expressly excluded. This EUSA sets forth the entire Licensee's rights and is the entire agreement between the parties. This EUSA supersedes any other communications with respect to the Software. This EUSA may not be modified except by a written addendum issued by a duly authorized representative of the Licensor. No provision hereof shall be deemed waived unless such waiver shall be in writing and signed by a duly authorized representative of the Licensor. The Licensee hereby acknowledges a breach of this EUSA would cause irreparable harm and significant injury to the Licensor that may be difficult to ascertain and that a remedy at law would be inadequate. The Licensee agrees that the Licensor shall have the right to seek and obtain immediate injunctive relief to enforce the obligations under this EUSA in addition to any other rights and remedies it may have. If any provision of this EUSA is held invalid, the remainder of this EUSA shall continue in full force and effect. The controlling language of this EUSA is English.
