We specify which Software this Migration Tool can be used for in our accompanying collateral. These terms do not affect or modify any of the terms of the licence agreement or terms and conditions governing your use of the Software (the "License Agreement").
- 2. We grant you a limited, non-exclusive, non-transferable, non-assignable, licence to download and use the Migration Tool only for your legitimate internal business purposes. The Migration Tool is licensed to you, not sold. You may use the Migration Tool only as expressly permitted in these terms. We reserve all other rights.
- 3. It shall be your responsibility to ensure that the data is in order once it has migrated and any reliance you place on the migrated data will be at your own discretion and risk.
- 4. The Migration Tool may feature technology that enables us to (i) collect information about how you use the functions and features of the Migration Tool and to help troubleshoot any issues; and (ii) gather statistical information about the operating system and environment on which the Migration Tool is installed.
